As recently posted on www.nynafg.com, the New GR meeting will be held on Thursday, May 19, 2022 at 7:00 PM on Zoom. On Friday, May 20th at 6:30 PM will be the Assembly Icebreaker, followed at 7:30 PM by the AWSC Meeting, both of which will be held over Zoom. On Saturday, May 21st starting at 9:15 AM will be the Spring Assembly Meeting, which will run until about 4:00 PM with a break for lunch. On Sunday May 22nd there will be an Alateen Interest Meeting at 9:00 AM on Zoom followed by Spiritual Speakers at 10:00 AM also on Zoom. The 2022 New York North Area Fall Assembly is scheduled for September, 16, 17, and 18, 2022 and will

My pattern before Al-Anon was always to react or respond to someone else's negative behavior, usually with a negative reaction of my own. By working through the 12 Steps of Al-Anon and listening to other members in meetings, I have learned that I do not have to respond to every word or action that upsets me and that I don't need to join in any argument that I am "invited to". If something is said that is very important to me, I can relate my thoughts and feelings and then let go of the rest. I also have learned that I don't need to always be a "caretaker" and that when I detach from trying to solve other people's problems, it almost always works out better for them without my "helping". I am grateful to all the Al-Anon members who have shared their own wisdom with me.
