Topic of the Month - "Awareness, Acceptance, Action"

The "Three A's" ... as they are known, remind me that my recovery is a process, and that it takes time. Prior to coming to Al-Anon, when I became aware of a problem, concern, crisis, feeling, or some new change in my life, my thought process was always to jump right to solving the problem or trying to avoid the feeling or making the change that I needed to make in my life because feelings and change are uncomfortable & I did not want to feel that way. I would do anything to avoid accepting change or any uncomfortable feelings. The part that I would skip over was acceptance. Whatever the issue, I learned in Al-Anon that I needed to take time to process the new element in my life & allow myself to let go, and accept things that I could not change, & then move on to take action on the things that I can change, & let go of what I could not. - Iim M.

On the topic of the "Three A's," I would say that any kind of unease in my life cannot be resolved without the Three A's. Unless I am Aware of what is REALLY bothering me, I can't address it, & things will just spin. I need to pause & ask my HP for help. Once I am aware of the issue, I can Accept that this situation is in my life right now & then, with my HP's help, I can determine the best Action to take. Sometimes, I don't need to take an action, but there is action in not taking an action - Maria S.

The three A's – awareness, acceptance, and action. What a timely topic for the start of the new year!

There were only two A's before Al-Anon – awareness and action. In my childhood home as soon as you were aware of something 'bad' you needed to leap into action to 'fix it'. I'm not sure how well this worked for my parents but I certainly know that it didn't work well for me. Leaping into action resulted in making rash decisions. Decisions that normally felt good now but never addressed the underlying issue. Therefore, the same issues continued to recur throughout my life. Over the years I've learned that until I truly accept a situation/issue any action taken will eventually cause me more pain.

I'm writing this article while in my previous home district – where I first came to Al-Anon. I'm standing at a laundromat counter typing away while doing my son's laundry. Spending time with my son is like standing next to someone holding a hand grenade. I never know when the pin will be pulled. So why am I here?

Awareness and acceptance have provided a small measure of patience to deal with him. He has a plethora of issues – cognitive delay, mental illness, substance abuse, and learned behaviors from growing up around the disease of alcoholism. Each interaction with him requires me to use all the tools in my Al-Anon toolbox – starting with the 'Three A's'.

Chauffeuring him around is an action I can do. Leaving him in the car with the dog while I do his laundry leads to a better outcome than to make him come in to do it himself. Other situations have taken a long time to accept before an appropriate action (appropriate for me) – leaving him in jail, calling the police when my safety is

at risk, refusing to take his phone calls, learning to keep my mouth shut when he speaks words or ideas I find offensive.

I share this with you as a gift that was recently given to me by other Panel 61 delegates – that no matter how long we have in the program there will always be challenges to face. Learning of the challenges other delegates have faced or continue to face blasted the terminal unique fallacy right out of my brain allowing a new view of how we all keep applying the '3-As'. – Kathi D

Awareness, Acceptance, Action ...

Pretty logical. But not always easy to do. Three simple words acknowledging how to change. = Awareness, acceptance & action. Discussing the disease of

alcoholism with a sponsee and discussing the 3A's the sponsee talked about her fear of crowds. The proper term for fear of

The topic for this month is "Awareness, Acceptance, and Action." This three-pronged approach to recovery enables us to reflect on our journey and share our personal experience, strength, and hope that might aid someone else in their quest to find the path to serenity.

Awareness is defined as "the knowledge or perception of a situation or fact". That being said, it is unbelievably difficult to apply this concept to your personal life when you are wallowing in the throes of someone suffering from addiction. It can be as plain and evident as the nose on your face, but acknowledging there is a problem can be a tough pill to swallow. It is even more challenging to do something about it. That is what Al-Anon taught me; and now I can honestly say that I am aware of the problem, and I have the tools of my program to help me fix it.

Before entering the rooms of Al-Anon, I had an extreme amount of difficulty wrapping my head around the concept of acceptance. I was filled with so much negativity and resentment toward my son and his addictions, I could not fathom the idea that I could find any degree of acceptance in our relationship or circumstances.

Thirteen years later, I look back on those dark days and wonder why I could not see the forest for trees. Al-Anon taught me to understand such slogans as "How crowds is enochlophobia So this person was uncomfortable going to an in person Al-Anon meeting.

In discussing her situation she was able to identify her fear and believed that she accepted her fear. To take action on it was not quite so easy. We do have zoom Al-Anon meetings. Perhaps that could be an introductory step to the meeting.

The action will hopefully be comfortable and eventually she may attend the meeting in person. The outcome is unknown at this time.

When dealing with the alcoholic I was aware of the drinking problem and that the drinking affected his behavior which very much bothered me. So I was aware. It was more difficult for me to accept the alcohol/drinking problem as objectively as the person with enochlophobia. I had to accept that alcoholism is a disease.

It was like alcoholism was a personal offense rather than a disease so the tools of Al-Anon had to be put to work.

important is it?" and "Let Go and Let God". I came to the realization that love and support would serve me much better, and the first thing I had to do on this journey was to accept the plan that my Higher Power had for me and for my son. While it took a while for us to get together and embrace the love that was hidden beneath the morass of anger and hate, we can now loudly proclaim at the top of our lungs that we truly love each other and accept each other for who we really are.

The final leg of this symbolic triangle is Action, defined as "a manner or style of doing something to achieve an aim". For too many years, my mantra revolved around the exact opposite – inaction. I sat back and allowed things to unfold or simply did nothing to alter the course of our relationship. I was on the slow boat to nowhere, and my fellow passengers on this voyage were grief, resentment, anger, and despair.

I entered the rooms of Al-Anon for the first time on April 3, 2010, and since that fateful encounter I have taken action to steer away from the maelstrom of hopelessness. I took control of my own life, chose to let my son handle his own recovery (with all of its ups and downs), and now both of us have found peace, contentment, and love in each other's lives. That is the beauty of Al-Anon. Through awareness, acceptance, & action, anything is possible! – **Mike R** Action was taken by regular attendance at meetings, using the tools, reading Al-Anon literature and talking to Al-Anon members on a regular basis. Eventually I was able to see the disease of alcoholism as an illness and not as a personal offense. I learned to trust in a higher power.

This was very enlightening to me. To be able to stand back and see how I could be more objective with the sponsee than I could with my husband. There were years of trust issues and resentments toward my husband while the sponsee is a person interested in Al-Anon and has a fear of crowds. For me, there is emotional intimacy with fellow Al-Anon members but it's not personalized as can be in relationships. So the 3A's may be easier or harder to work depending upon our situation.

Thank you, Lois, and all for the Al-Anon program.

I have been a student of Al-Anon since 2015 and I have never really studied the 3 A's until given this assignment. I took the time to read the passages in all 3 of our books. What stood out in one of the articles was saying that dealing with a problem, awareness is often followed by a period of acceptance before one can act. Which one of my young children would be affected by their mother and father's ridiculous dancing?

I distinctly followed a pattern when a problem arose. I think I followed these steps perfectly as anticipated, yet unconsciously habitual. Because most of my married life was lived walking on eggshells, even when I was baited into an argument, I still followed the 3 A'a chronologically. If I didn't and reacted to the problem, a worse argument would ensue, and a resolution would never occur. This made for a miserable life.

As I grew with my program, in retrospect, I slowed down my thought process and knee jerk reactions before I acted, if at all! My alcoholic became antagonized with my delayed reactions and would try to punish me verbally, more. But I didn't let anything interfere with implementing my tool usage and consequently I unlearned my past behavior and response and became less baited. In fact, the whole baiting and dancing lessened.

"Group Finance Guidelines" – (Shall be published in the January NHL each year):

The Suggested Guidelines for Group Treasurers (which includes NYN mailing address) should be published in the Area newsletter each January.

Tradition Seven: Every group ought to be fully self-supporting, declining outside contributions

In keeping with Tradition Seven, A group's membership is the source of its funds. Assistance from sources outside of Al-Anon or Alateen violates this Tradition. There are no dues or fees to attend Al-Anon or Alateen meetings. . . . Group funds are used to support Al-Anon's purpose of carrying its message of help and hope to those who still suffer.

Group contributions support all levels of Al-Anon service including the District, the local Al-Anon Information Service (AIS/Intergroup), the Area, and the World Service Office (WSO).

Groups are within their autonomy to create a financial budget to plan for the purchase of literature, refreshments, the group's trust servants' expenses to attend business meetings, purchasing *Al-Anon Faces Alcoholism* as a public outreach project and contributions to the service arms. Some groups take additional collections for special local projects within the District or Area. If necessary, groups can add to the voluntary contributions by having fundraising events. (See "Financial Matters" in the "Digest of Al-Anon and Alateen Policies" section of the *Al-Anon/Alateen Service Manual.*)

Warranty One: That only sufficient operating funds, including an ample reserve, be its prudent financial principle.

The spiritual principle of prudence suggests that groups avoid accumulating money beyond current needs and a small but ample reserve, with just enough funds to pay the GR expenses to Assembly and group expenses for a couple of months. This can be decided by making an informed group conscience decision. (See *Reserve Fund Guidelines* [G-41]).

Group expenses may include:

• Rent (may include insurance) for a meeting place. If necessary NYN carries a policy that covers groups.

- GR's expenses to attend and participate at District and Area Assembly meetings.
- Al-Anon Information Service (AIS/Intergroups) Representative (ISR) expenses to attend and participate at the AIS meetings.
- Conference Approved Literature, including Al-Anon and Alateen books and pamphlets for sale to members. Most groups offer lowpriced pamphlets and leaflets to newcomers and members at no charge.
- Miscellaneous expenses agreed to by the group conscience such as babysitting, public outreach activities, refreshments, etc.




