A Group Name that includes the town, or section of the town, the meeting day or phrase from our program would be appealing. A group's name should not imply affiliation with any other twelve-step group, self-help group, commercial venture, religious group, rehabilitation facility, or other outside enterprise, even if associated with its location.

A contact person should be aware that the WSO might give a toll-free meeting callers their first name and phone number. Contacts may receive calls from potential newcomers who have had no previous contact with Alateen or from visitors needing directions, etc.

Alateen Registration/Group Records changes and Al-Anon Members Involved in Alateen Service Status changes are ongoing. It is important that you assist the WSO by maintaining complete, updated records in order to help keep. Alateens safe.

In order for the WSO to continue as a valued and trusted resource for families in need, Al-Anon Family Groups must always be knowledgeable about _ whom our children are with and where the meetings are located at all times.

The committee has withdrawn their proposal to change the dynamics of our assemblies and conventions at this time. It is suggested that a long range planning committee could be established to work on this issue as well as others.

The committee has consolidated the numerous documents regarding assemblies and conventions into one document that covers the guidelines for both. There are 3 issues th need to be addressed by the assembly before the guidelines can be finalized.

The following are those issues and the committee's recommendations regarding them.

- 1. That the name of the Spring Convention be changed to Spring Assembly. This would more accurately reflect the working portion of the weekend. The Spring Assembly would still have panels in the program for all those attending who do not need to participate in the working portion of the weekend.
- 2. That the AWSC meeting should be held on Saturday mornings in the Fall. That it should be held at the same time as the New GR meeting.
