 - c) Group 3 Gwen D22 reported. What could we do to encourage the Alateen participation (members, groups, sponsors) at the Area Assemblies?

- Scholarships to help pay their way, focus on 1 Assembly or Convention.
- Be willing to be flexible with timing of assemblies/conventions to not conflict with Prom, sports, etc.
- Have a sponsor willing to bring them.
- Go to NYNAC-ask for Alateen ideas on what would interest them.
- Alateen speakers-others will come to support.
- Involve teens? Responsibility for choosing recovery topics and/or icebreakers i.e. Hugs for Healing
- Have an Alateen liaison to sit at head table and have impute on planning committee etc.
- Have DR express to teens the value of their imput to us.
- d) Group 4 LaVuagh R. reported. **4.** Is our Area supporting the groups and the districts well? Although 46 people said "yes" and only 4 said "no", many of the written comments reflected less than positive concerns such as "could be more support", "sometimes feel alone", "would like traveling service presentations", "no connection to the area that is visible", "still have dark districts"
- Using KBDM our group came up with the following:1. What do we know about our members' or prospective members' needs that is relevant to this discussion? That we as an Area are not meeting their needs through the use of the Area web site, Northern Hi Lights or Area Conventions/Assemblies.
- 2. What do we know about the resources and our vision for the organization that is relevant to this discussion? That the Area has many past and present officers and coordinators with a great deal of experience, strength and hope to share. It should be possible to bring a half-day workshop to the western, central and eastern portions of our Area. The key is to make it fun while sharing useful information enthusiastically.
- 3 What do we know about the current realities and evolving dynamics of the world and our fellowship that is relevant to this discussion? What are the Pros and Cons?
- The attitude today seems to be one of "What's in it for me?" while our younger generations live by texting. It may be difficult to get people to turn out.

: Alternate Delegate Spring AWSC meeting March 26, 2011 Hot Topics

- 1. I sent welcome packets to seven new groups to the New York North Area. One group in Western New York is a Spanish speaking meeting. I was able to find a translation program so the welcome letter was in Spanish.
- 2. I received the first memorandum of the year from the Forum WSO staff liaison in February.
- a. Our first job is to encourage every group in our area to take advantage of the complementary copy of the Forum that each group receives each month.
- b. Our second job is to encourage more members to make the Forum a part of their personal Al-Anon program by reading and writing for the Forum.
- 3. New York state subscriptions are down 18 compared with the loss of two groups from August 2010.
- 4. As of February the ratios went from 1.33 subscriptions/group last year to
- 1.29 subscriptions/group. As a point of clarification, the WSO does not separate New York North and New York South numbers. The WSO has set a goal of 2.0 subscriptions per group for each state.
- 5. We are compiling a list from New York North of how groups use the Forum during a meeting and how groups encourage members to have their own subscription.

Sponsorship is a mutual and confidential sharing between two Al-Anon or Alateen members. Alateen Personal Sponsors Just as Al-Anon members sponsor each other, Alateens sponsor each other. Alateen Personal Sponsors are fellow teenagers who can discuss personal problems or questions with those they sponsor. Personal Sponsors willingly share the experience, Strength and hope of the Alateen program.

I'm hoping to send District Representatives a list of their Al-Anon Members Involved In Alateen Service. I would like them to let me know if everyone is still residing in New York State and are still interested in being involved as an AMIAS. I will be updating the Alateen information with the printout. Anyone interested in being an Alateen sponsor must regularly attend Al-Anon meetings for at least 2 years. Any Alateen that has moved on to Al-Anon interested in sponsoring an Alateen group must attend Al-Anon

meetings regularly for 2 years before sponsoring Alateens and must keep attending Al-Anon meetings. Members of Alcoholics Anonymous and Al-Anon must attend Al-Anon for two years before becoming a Sponsor or AMIAS. This is done to protect the safely of our Alateen members. Any Al-Anon member involved in Alateen service must be active in Al-Anon meetings. Every Al-Anon group should consider sponsoring an Alateen group. Teens deserve recovery just as much their parents.
